Commercial Building Permit Fee Calculation Estimate

Permit fees are calculated based on the value of the contract cost of the building/tenant finish or the minimum value from the City of Arvada construction table based on the type of construction which ever is greater.

Permit fees are based on this table. 18-1

Total Valuation	Fee
\$1.00 to \$500.00	\$26.00
\$501.00 to \$2,000.00	\$26.00 for the first \$500.00 plus \$3.37 for each additional \$100.00 or fraction thereof, to and including \$2,000.00
\$2,001.00 to \$25,000.00	\$76.61 for the first \$2,000.00 plus \$15.49 for each additional \$1,000.00 or fraction thereof, to and including \$25,000.00
\$25,001.00 to \$50,000.00	\$432.84 for the first \$25,000.00 plus \$11.17 for each additional \$1,000.00 or fraction thereof, to and including \$50,000.00
\$50,001.00 to \$100,000.00	\$712.18 for the first \$50,000.00 plus \$7.74 for each additional \$1,000.00 or fraction thereof, to and including \$100,000.00
\$100,001.00 to \$500,000.00	\$1,099.39 for the first \$100,000.00 plus \$6.20 for each additional \$1,000.00 or fraction thereof, to and including \$500,000.00
\$500,001.00 to \$1,000,000.00	\$4,197.03 for the first \$500,000.00 plus \$5.25 for each additional \$1,000.00 or fraction thereof, to and including \$1,000,000.00
\$1,000,001.00 and up	\$6,824.49 for the first \$1,000,000.00 plus \$4.04 for each additional \$1,000.00 or fraction thereof.

Plan review is 65% of the building permit fee.

Electrical is contract value and use the table fee.

Mechanical is contract value and use the table fee.

Plumbing is contract value and use the table fee.

Use tax is 3.46% multiplied by half of the value assessed to the building.

There is a temporary construction meter fee of \$ 44.00.

Building permit fee + construction meter fee (\$ 44.00) + electrical fee + mechanical fee + plumbing fee + use tax + plan review = building permit fee.

Example: Cost to Build Building = 100,001.00

1105.59+44.00+ (Elec. assumed 10%of building contract and apply to chart) 216.02+ (same for Mech.) 216.02+ (same for Plumb.) 216.02 + (50000.50x3.46%) 1730.02+ (65%x1099.39) 714.60= \$4246.30

1105.59+44+216.02+216.02+216.02+1730.02+718.63= \$4246.30

Tennant finish is calculated the same way based on contract value of the project.

Note that Electrical, Mechanical and Plumbing will be based on the actual value of the work. The 10% is used for the example only. There may not be electrical plumbing or mechanical but we will only charge for the work being done.

Signs are separate permits and need to be reviewed by Community Development.

Sign Permit Fee 40.00+ 3.46% x half the contract value.

1000.00 dollar sign = 40 + 3.46% x 1000= \$ 74.60 with electric /electrical contractor required.
