

Current Study Efforts

Work on the project began in early December. A Stakeholder Committee was formed which is designed to get input from key representatives of the business community, surrounding neighborhoods and other institutions that could be impacted by an increase in parking demand. Through a competitive process, the City hired a consulting team to assist city staff in conducting the project. The consulting team consists of Carl Walker Inc., a firm specializing in parking and Urban Trans, a firm specializing in transportation demand management. The team has a great deal of experience in working with communities such as Arvada.

Representatives of Carl Walker Inc. were in town the week of December 8th to assemble data necessary for the project. An inventory of parking was taken and occupancy and turnover studies were performed. Some people may have noticed people with clipboards walking around and writing down license numbers. If you observed such a thing, it was probably one of the parking consultants doing their work. Please note that only the last three digits of license numbers were recorded and the purpose of this exercise is to determine the turnover rate of on-street parking. License numbers will not be used for any other purpose or published in any report.

On December 11th, public participation for the project began with a Stakeholder Committee Meeting and Public Meeting. The purpose of these initial meetings was to introduce the project and gather input and what people see as the issues and opportunities associated with parking and using alternative transportation to reduce parking demands. Please see the sections of the website which contains presentation materials and questions regarding issues. The website also contains information regarding how to be involved in the future.

The information collected during the December 2008 meetings was summarized and presented at the second round of stakeholder and public meetings on January 21, 2009.

Additional public input was sought on April 14 and 15, 2009. These public meetings focused on possible strategies to address identified issues.

The Draft Plan is now being discussed with the Stakeholder Committee and public. Public meetings will be held January 27 and 28. See the Public Meeting Flyer under "What's New".
